### Global reach

The Beazley healthcare claims team is based in New York and London, and handle claims across the globe. Although the jurisdictions vary in terms of local laws and customs, we have found that the challenges to healthcare providers and complexities of a medical malpractice claim are universal.

### Claims example

The insured was a healthcare institution based in the United States, it was taken to court following a claim involving the amputation of a patient's limbs following a post-operative infection. The lawsuit was brought against Beazley's insured in a challenging jurisdiction, and the plaintiffs were represented by tenacious counsel. In this regard, the plaintiffs' made multiple demands in excess of \$50,000,000, and their counsel refused to engage in meaningful negotiations. Subsequently, Beazley partnered with our insured and collectively decided to take the case to trial. Although the adverse

verdict potential was significant, Beazley agreed with the insured that a settlement in the range contemplated by the plaintiffs was unwarranted given the strength of our defenses. After several weeks of trial, the trial court issued a directed verdict for the defense.
