**Minimum premium:** \$7,500

## Contractor's equipment

Provides coverage for a contractor's equipment and tools. Available on either a stand alone basis or as part of a Master Builders Risk program. Coverage is included for newly acquired equipment, leased, rented or borrowed equipment, rental reimbursement, miscellaneous tools, and pollution clean up.

**Limits:** Up to \$25,000,000

**Minimum premium:** \$1,000

**Minimum deductible:** \$500

**Appetite:** All classes except loggers and paper recycling.

## Rigger's liability coverage

Provides coverage for property of others in the Insured's custody or control while being lifted, hoisted or installed. Coverage can be provided for a single lift or for an insured's annual exposure.

**Limits:** up to \$5,000,000

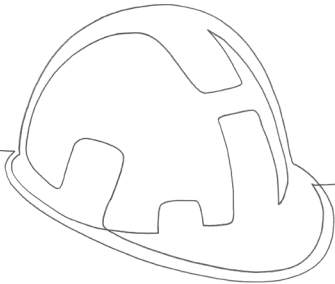
